Alas, our monetary giving has been a little low in the last few months. Over the coming weeks, we need to consider how to improve our financial giving to our church. It was discussed at length at last month's council meeting. A couple things were brought up that the congregation needs to be aware of. First, every month a portion of the giving is automatically set aside to go towards synod benevolence. Whatever is collected in the basket that is specially marked as "benevolence" is considered above and beyond what we already give to synod through the automatic deductions. Second, perhaps we might consider setting up automatic weekly giving or "e-giving." For a fee, we can use a program that allows members to give without being at worship services. Better allocation and giving options have potential to grow our giving.

God has blessed us with so much this year and we need to be mindful of how best to manage our blessings. Let us honor God for all the blessings in our congregational giving.

I was blessed to be able to get away and attend not only the synod's fall theological conference in Kearney but also an annual Barbershop Chorus contest in Cedar Rapids, IA. There were 13 choruses in the Midwest conference that competed and I think our rousing renditions of the "Monster Polka" and "Transylvania Mania" were the most entertaining, if not technically superior to what the other choruses presented. What a fun group of guys to sing with!

Trinity Lutheran Church Minutes

September 21, 2016

I. Call to order

Chairperson Brian Nelson called to order the regular meeting of the Trinity Lutheran Church Council on September 21, 2016. Pastor Koos led the group in devotions. Members in attendance were Pastor Koos, Duane Wollenburg, Brian Nelson, Jane Stokebrand, Lois Wattjes, Joel Kaelin, RandyWollenburg. Jesse Gronemeier, and Adam Wollenburg.

II. Reports

- Secretary's Report: A copy of the previous minutes was presented. It was moved by Lois and seconded by Randy that the minutes be approved. Motion carried.
- b) Treasurer's Report: A copy of the monthly treasurer's report indicated a balance of \$10,6700. There was a motion by Jesse and a second by Joel that the report be approved. The motion carried.
- c) Investments Report: The investment balance is \$36,885.22.
- d) Pastor's Report: See included report.
- e) Memorial Report: Balance of Memorial Fund to date is \$20,519.40.
- f) Suggestion Box: None submitted
- g) Committee Reports:
 - Social Committee reported plans for October 23, 2016 to attend the Community Players
 production of "Steel Magnolias" at 2:30 in the afternoon. A hayrack ride is scheduled for
 November 13, 2016 from 2:00 to 4:00 to be followed by chilli, cider, and cookies at the
 church from 4:30 to 5:30. A Lincoln Stars hockey game will be held January 28, 2017. A
 card tournament and game day are planned for February 26, 2017.
 - 2. Worship Committee reported an updated schedule for music to include selections of a Christmas Cantata and the possibility of a brass band for preludes for Christmas.
 - 3. Parish Education and Youth Group Ministries reported that enough Sunday School teachers have volunteered to provide five groups of classes with two teachers per class. Monthly Sunday School committee meetings were initiated in August. The Care-A-Lot program will have a new focus this year to include a mentor and mentee approach. This will be held the first Sunday of the month during the Sunday School hour.
 - 4. Property Committee reported that the bathroom walls and trim in the parsonage basement are yet to be completed. There is a light not functioning on the east side of the church which will be replaced. Property committee will determine if there is any warranty on that item.

III. Old Business

- a) The painting of the parking lot lines is scheduled.
- b) There was a motion by Adam and a second by Jesse to purchase materials from Sack Lumber for insulation and siding for the free standing garage at the parsonage. Jesse will head that project.
- c) Installation of speakers in the chapel was tabled for the time being.
- d) The financial secretary will submit the final payment of \$10,000 to James Pittman for the church roof.

e) Payment of donations from the Fiftieth Anniversary celebration will be tabled until the next meeting.

IV. New Business

- (a) There was a motion by Lois and a second by Adam to grant transfers out for Maci Hicks and Heather (Schwan) Baker. The motion carried.
- (b) Pastor Koos reported that Mr. Bill Biggs from the ELCA has contacted the church indicating there are some new required amendments that need to be made to our constitution after the ELCA Model Constitution was recently amended. These minor changes were discussed and will be submitted to the synod.
- (c) A New Member class is scheduled to begin September 21th.
- (d) There will be a joint service with Soap Creek Church on October 30th at Soap Creek. Communion service for October will be moved to Sunday the 23rd.
- (e) Pastor Koos requested and was granted time off for October 7th and 8th to participate in a Homestead Harmonizer performance in Cedar Rapids, Iowa. Pastor will be back for Sunday service.
- (f) The weekly adult Bible study will be rescheduled to Wednesdays from 8:30 to 9:30 to accommodate the needs of participants. Pastor will include questions in the News Letter as preparation for the classes.

Adjournment: There was a motion by Duane and a second by Randy to adjourn the meeting. The motion carried. In conclusion of the meeting, Pastor Koos led the group in praying the Lord's Prayer. The next council meeting will be held on October 19^{tht} at 8:00 P.M. Communion Assistant for October 23rd is Joel Kaelin.

Bible study questions Wednesdays, 8:30 a.m. November 2016

11/02/16 Luke 6:20-31

- 1. What is surprising about the statement that Jesus makes? Would you consider being poor to be a blessing?
- 2. Compare this with Matthew 5:3. What does Jesus emphasize in the Sermon on the Mount? What might this tell us about the kind of poverty that Jesus is referring to?
- 3. Read James 1:9-10. What does James tell the poor man (lowly) to glory in (rejoice in)? What does he tell the rich to glory in? How would these two exhortations relate to the passages in Matthew and Luke?
- 4. Is Jesus promising that all the world will be fed? What is the promise to those who hunger? When will this promise be received?
- 5. If we follow Christ with all our hearts, will everyone like us (1 Timothy 3:12; John 15:18-20; John 17:14; Philippians 1:28-30)?
- 6. How does Jesus tell them to respond when they are persecuted? What are the two reasons he gives them? How do rewards motivate us to live for Christ even when we are suffering?
- 7. Why does Jesus pronounce a "woe" upon the rich? Would it be fair to say that they have gotten all they are going to get (if they do not have Christ)?
- 8. What does he say to those who are full? Does this mean that we cannot eat and be full? What is he referring to?
- 9. Is laughter wrong? Why does James say that we should mourn rather than laugh? How is this related to what we have studied in this passage?
- 10. Why should we beware when people speak well of us? What does this make us think about ourselves? What is the danger of listening to men's praises (Romans 16:18; Proverbs 29:25; John 9:22)?

11/09/16 Luke 21:5-19

- 1. What is Jesus responding to in verse 6 and why does He respond this way? How do we fall into that same trap?
- 2. What are the two purposes for Jesus telling His disciples about the end times? Two temptations that people fall into when talking about the end times is to set out to predict when it is going to happen or to be worried that it is going to happen at all. How does Jesus address this and do you fall into either of these categories?
- 3. Why does Jesus respond with a warning instead of direct answer in verse 8? What two things does Jesus say will not be signs that the end is near? What does this say about people who claim to know that the end is near?
- 4. What two things will begin to fall apart as we approach the end? What does verse 9 say about the suddenness of the end? Why does Jesus tell us not to fear?
- 5. Talk about what sparked Jesus' reply. What is Jesus saying about admiring too closely the things of this world? What is the tendency for us to be awed by this world?
- 6. What shift does Jesus make in verse 12? What does Jesus promise will happen? How quickly does this begin to happen (Acts 5:17)?
- 7. What different things does Jesus prophesy will happen? Scan through Acts and write down an occurrence that each one of these comes through.
- 8. Jesus says not to "prepare before hand" (NASB) upon how we are to answer. Does this mean that we are not to study and have a defense for our faith when asked (Romans 12:2; 2Timothy 2:15; 1Peter 1:13)? If so, what does Paul and Peter mean in these versus? If not, what might Jesus mean?

- 9. Betrayal by friends, relatives, or anyone is hard, if not devastating. What example does Jesus present for us about how to handle betrayal? Do you look to Christ when you feel betrayed? Are Jesus' words sobering or encouraging? Why?

For the Christian, then, the issue is not whether there is conflict, but whether the inevitable conflicts are instructional and growth-producing. How might that lesson apply to your life? - 8. A well known contemporary Christian speaker calls Jesus his "commander and chief"? How does that adaptation of the phrase "Jesus is Lord" strike you? What might it say about who Jesus really is?
- 9. What makes leading as Jesus calls us to different from common expectations of leadership?
- 10. What does the thief on the cross who defended Jesus in Luke 23:39-43 teach us about Christian leadership?


