I. Call to order

There was a motion by Duane and a second by Joel to pay \$6,250 as 50 per cent of the payment from the Fiftieth Anniversary donations to the Nebraska Lutheran Campus Ministry. The motion carried. No payment has yet been made to the other designated beneficiary, Nebraska Synod Disaster Relief Fund
- c) Investments Report: The investment balance is \$37,035.31.
- d) Pastor's Report: See included report.
- e) Memorial Report: Balance of Memorial Fund to date is \$20,521.37.
- f) Suggestion Box: None submitted
- g) Committee Reports:
 - 1. Social Committee reported no additional plans since the previous meeting.
 - 2. Worship Committee reported the purchase of an electronic piano at a cost of \$2,800 with payment provided by Thrivent.
 - 3. Parish Education and Youth Group Ministries reported the first committee meeting for that group was held on the third Sunday of the month.
 - 4. Property Committee reported that work on the parsonage basement has been completed to include bathroom walls and trim around the windows. The underground sprinklers for the parsonage and church have been drained and winterized. It was reported that one exterior church light currently is not functioning.

III. Old Business

- a) The painting of the parking lot lines has been completed, and work on the unattached garage is pending.
- b) There was a motion to accept Lonnie Groathouse as a member of Trinity Lutheran Church. The motion carried.
- c) The required constitutional revisions will be available for review and will be voted on by the congregation after church on November 6, 2016.
- d) Pastor reported a productive Fall Conference meeting.
- e) The benches for outside the church have been purchased and are expected after Thanksgiving.

IV. New Business

- (a) Pastor Koos requested and was granted vacation from December 26th to January 1st.
- (b) There was discussion regarding developing a New Member packet to be designed for people interested in joining Trinity Lutheran Church.
- (c) Brian will contact John McGary about the Christmas tree for the church.

12/07/16 Matthew 11:2-11

- 1. Who was John the Baptist?
- 2. Why did John the Baptist doubt that Jesus was the Christ?
- 3. Why did Jesus give the two disciples an indirect answer?
- 4. How can we overcome doubt in our lives?
- 5. What was Jesus' witness concerning John?
- 6. Why did so many fail to believe John and Jesus?
- 7. What do you learn about John? Who is more important? How important do you believe that John is?
- 8. Explain in both the literal and metaphorical senses: "the blind regain their sight, the lame walk, lepers are cleansed, the deaf hear, and the dead are raised." John asked Jesus if he was "the one who is to come." Jesus answered with the above statement. The people who came to John were seeking the deepest desires of their hearts. How was Jesus' response an answer to those desires?
- 9. John the Baptist might have expected a mighty one and was confused at the gentle, healing Jesus. Does God always come into your life the way you expect? Explain.
- 10. Who are the prophets in your life? Why is listening just as important for a prophet as speaking?
