## Trinity Lutheran Church Minutes

February 21, 2018

## I. Call to order

Chairperson Brian Scherling called to order the regular meeting of the Trinity Lutheran Church Council on February 21, 2018. Pastor Koos led the group in devotions. Members in attendance were Pastor Koos, Brian Scherling, Mike Holtmeier, Yvonne Rahe, Byron Beerenstrauch, Nate Morrissey, Karen Wollenburg, Steve Garrison and Amy Stokebrand

## Reports

- a) Secretary's Report: A copy of the previous minutes was reviewed. Mike made a motion and it was seconded by Yvonne that the minutes be approved. Motion carried.
- b) Treasurer's Report: A copy of the monthly treasurer's report indicated a balance of \$8,779.73 as of January 31, 2018 with available cash of \$6,789.50. Steve made a motion to accept the report and it was seconded by Byron. Motion carried.
- c) Investments Report: The investment balance as of January 26, 2018 is \$56,095.75. Steve Hovendick from Edward Jones was invited to the meeting. He explained how our funds are being invested. The balance as of February 18 is \$53,519.38. He felt like we are in good position to continue on with our investing strategy.
- d) Pastor's Report: See included report. Pastor reported that the First Communion Class will be starting on February 25<sup>th</sup> for 4 weeks with 3 students. The Rural Ministry Conference will be March 4-6<sup>th</sup> so Pastor will be gone during that time.
- e) Memorial Report: The memorial balance is reported to be \$15,443.68 as of February 21, 2018.
- f) Suggestion Box: No report.
- g) Committee Reports
  - 1. Social Committee had no report.
  - 2. Worship Committee reported on the service schedule for the upcoming month. Children's Bells will be Feb. 11<sup>th</sup> with a guest Preacher: Dennis Rock. Ash Wednesday service will be Feb. 14<sup>th</sup> and the Adult Choir will sing. The Adult Choir will sing on Feb. 18<sup>th</sup>. Feb. 21st will start the Lenten services with a light supper before the service. They are still in need of people to sign up for the light meal. Feb. 25<sup>th</sup> will be communion service with the Sunday School singing. March 4<sup>th</sup> will be the Praise service with the Praise Choir. The Methodist Church will host the 10:00 Thursday morning Lenten Services. March 29<sup>th</sup> will be the Maundy Thursday service with 1<sup>st</sup> Communion for the 3 students. April 1<sup>st</sup> will be the 7:30am Easter Sunrise Praise Service with the Youth Group providing a Breakfast followed by the 10:00 worship with the Band. April 22<sup>nd</sup> will be a Baptism for Finley Oliver. Confirmation will be April 29<sup>th</sup>. May 6<sup>th</sup> will be the Sunday School Teacher Appreciation Breakfast and the High School Graduation Recognition with 9 students.
  - 3. Evangelical Committee had no report.
  - 4. Parish Education/VBS reported that the last day for Sunday School will be May 6<sup>th</sup> and that is the last day for Jana Muehling as the Sunday School Superintendent. Josie Hoesche will be taking over for next year. Vacation Bible School will be May 29-31<sup>st</sup> this year with a short VBS program during church on June 3<sup>rd</sup>.
  - 5. Youth Group reported that they want to paint their meeting room. They will get businesses to donate the paint and supplies. They want to get this done in late February.
  - 6. Confirmation Committee had nothing to report.
  - 7. Property committee reported that the Church Clean-Up day will be March 24<sup>th</sup> with a rain date of April 7<sup>th</sup>. During that time, the church will be looked at to see if there are excess

items in the church that are not used any longer and if they can be gotten rid of. The service plan for the heating and air conditioning will be \$100 more per year for 2018.

## II. Old Business

- a) WELCA would like to purchase 12 round tables for the Fellowship Hall at \$180 each plus a cart to store them from Costco. The company will deliver the tables. The tables seat about 10 per table. The long tables will be kept in case they are needed. Steve made a motion to allow WELCA to purchase the tables. Nate seconded the motion and the motion carried.
- b) Goals for the Church Council were mentioned and we are looking for more ideas for the upcoming year. Some of the ideas were to look at the materials for Confirmation class, getting feedback on services and funerals, look at sharing resources with area churches without losing our identity and lastly being more fiscally responsible.
- c) The Executive Committee will be getting together in the coming weeks to work on employee reviews for the other paid positions of the Church: Secretary, Financial Secretary and Custodians.

## III. New Business

- a) The Executive Committee recapped the Pastor's Performance Review. The four points of discussion were Confirmation, Sermons, Organization and Accessibility.
- b) The church newsletter was discussed because of the cost and time that goes in to producing it each month. Jenn mails out 139 newsletters so the council will look into other options to get this to our members.
- c) It was discussed that the Acolytes should wear nice clothes instead of shorts.

There was a motion by Mike and a second by Steve to adjourn the meeting. The motion carried. The next meeting will be March. 21<sup>st</sup> at 8:00pm. In conclusion of the meeting, the council recited the Lord's Prayer.

## Bible Study Questions Wednesdays, 8:30 a.m. April 2018

### 04-04-18 John 20:19-31

- 1. What was the atmosphere of the room before Jesus entered the room? How about after? Why?
- 2. Why did they fear their fellow Jews? John 7:10-13; Proverbs 29:25; Philippians 1:12-14
- 3. Why didn't Mary's testimony of Christ risen from the dead seem to matter to the disciples? *Luke 24:9-11; Mark 16:9-11*
- 4. Why did the disciples need to hear Jesus' words and why were they repeated? Vs.19, 21
- 5. Verse 23 can be confusing. Taking the Scripture verse into account, what do you think it means? *Luke* 5:21-26
- 6. Why do you suspect Thomas was not with the others cowering upstairs? Hebrews 10:23-25
- 7. Why did they wait 8 days to meet again (This would have had them meet on Sundays)? Acts 20:7; 1 Corinthians 16:2, 16-17
- 8. When Jesus finally saw Thomas, what did He ask Thomas to do? Why? *Verse 25 What does this tell us about Jesus?*
- 9. Why didn't Thomas believe, even after the other apostles and women told him that Jesus had risen?
- 10. How does the story of Doubting Thomas, speak to rebellion, passion and change?

## 04-11-18 Acts 9:1-19a

- 1. Read Romans 9:1-19. Saul traveled 150 miles to Damascus in order to expand what started as a local persecution against believers in Jerusalem (See Acts 8:1). What does this tell you about him?
- 2. Saul's former teacher was Gamaliel (see Acts 22:3). What did Gamaliel advise the Sanhedrin regarding Christians in Acts 5:34-39? How does Saul respond to this advice?
- 3. How do you think Saul felt when confronted by Jesus (Acts 9:4-6)? Given his previous activity, what would he be thinking about during those three days of blindness and fasting?
- 4. How would you act in Ananias' place? Since Jesus had already appeared to Saul directly, why this time would he want a person to go to him? What is significant about the way Ananias addresses Saul?
- 5. Re-read Acts 7:54-8:3. Discuss how that incident might have been the impetus of Saul's actions.
- 6. Why do you think Saul is so fervent in his persecution of the church?
- 7. What was Paul's understanding of God before his conversion?
- 8. What was your understanding of God before your conversion? How did that understanding change after your conversion?
- 9. Read John 6:44 and John 15:16. Discuss how these verses shed light on the story of Saul's conversion.
- 10. What is the significance of Jesus' statement that Saul is persecuting Him?

## 04-18-18 Acts 16:16-34

- 1. Describe the condition of the three people (Lydia, the slave girl, and the jailer) who encounter Christ in this chapter.
- 2. What encouragement or hope is drawn from the fact that God saves each of those people?
- 3. Notice how Paul and Silas handle their imprisonment in verse 25. How does our response to adversity/trials empower our witness?
- 4. What was it that motivated Paul and Silas to stay, even when the chains had been broken? Can you think of any examples where a Christian's commitment to a higher authority would lead them into harm's way?

- 5. Notice that with the jailer and his family, the ministry of the Word was essential to his faith. How confident are you in your abilities to explain and share God's Word? What steps could you take to be more prepared?
- 6. How were Paul and Silas behaving in prison? What do you think motivated them to act this way in this circumstance?
- 7. How would you have responded if you were suddenly freed from a wrongful imprisonment? How did staying lead to God being glorified?
- 8. Why should we praise God even when doors seem closed to us?
- 9. What doors has God opened for you?
- 10. How do you discern what is a closed door and what is an open one, when it is not crystal clear?

## 04-25-18 Acts 17:16-31

- 1. What kinds of philosophies and beliefs did Paul encounter in Athens?
- 2. How would you describe the people of Athens that Paul spoke with—cultured or uncultured; intelligent or unintelligent?
- 3. How do we cope with a world that knows or cares so little about the truth of Jesus Christ? What did they misunderstand about what Paul was preaching? Is the resurrection of Jesus as unusual to people today as it was to Paul's listeners in Athens?
- 4. How did the people respond to his preaching? What kinds of comments might we encounter as we preach and teach about the resurrection?
- 5. What evidence would you give for the reality of the resurrection? What evidence for the resurrection do you find in John 19:3335; John 20:6-8; and 1 Corinthians 15:3-8?
- 6. Read Acts 17:22-28. How does Paul begin his message to the philosophers? What important principle can we learn for witnessing to those who differ greatly from our beliefs?
- 7. Does God need anything (Psalm 50:8-13)? What aspect of God's character is Paul referring to? Why is this important to understanding God and salvation (Romans 11:33-35)?
- 8. What seemingly obvious statement does Paul make about idols and God (Psalm 115:4-8; Isaiah 44:9-20)? Why do people everywhere misunderstand this (Romans 1:18-23)?
- 9. What does Paul declare about this God that they do not know? What aspects of his nature and character does he include?
- 10. Read Acts 17:29-31 and John 5:20-29. Talk about idols. What are they and why are they such an offence to God?



Over the next couple of months, the Church Council is requesting feedback from our Trinity Congregational members. Please give our request careful consideration and respond back in a timely manner.

In an attempt to help decrease expenses here at Trinity, we are once again asking for your feedback concerning the mailing of our monthly newsletter. Currently we are mailing out approximately 140 newsletters every month. This ends up costing the church over \$1000 per year. We are hoping to cut some of this postage expense if possible. Pastor is emailing the newsletter every month to a large number of congregational members. So, some members are getting one in the mail and an electronic version from pastor. We understand that not everyone has access to email and there are some that do not read their emails, so we will not eliminate either of these options. The newsletters will continue to be published monthly. It is our intent to give the members numerous options to receive it, while being more efficient with our time and money. We are asking that you please give this thoughtful consideration to help our church manage this expense. Listed below are the three delivery options that the congregation will have access to.
