Trinity Lutheran Church Minutes

January 16, 2019

I. Call to order

Chairperson Mike Holtmeier called to order the regular meeting of the Trinity Lutheran Church Council on January 16, 2019. Pastor Koos led the group in devotions. Members in attendance were Pastor Koos, Steve Garrison, , Karen Wollenburg, Tim Garrison, Brian Smidt, and Jane Stokebrand.

Reports

- a) Secretary's Report: A copy of the previous minutes was reviewed. Steve made a motion and it was seconded by Brian that the minutes be approved. Motion carried.
- b) Treasurer's Report: A copy of the monthly treasurer's report indicated a balance of \$19,373.17 and a benevolence balance of \$587.54 as of December 31, 2018. Tim made a motion to accept the report and it was seconded by Karen. Motion carried.
- c) Investments Report: The balance was reported at \$4,850.56 as of December 31, 2018.
- d) Pastor's Report: See included report. There was a request for transfer by Eric Stokebrand and Thomas Stokebrand to Christ Lutheran Church, Louisville, NE. Tim made a motion and Steve seconded the motion to grant the transfer. The motion carried. Pastor requested four vacation days for the upcoming year to include June 23rd, August 4th, October 13th, and December 29th. Pastor will be attending the Rural Ministry Conference March 3rd through 5th.
- e) Memorial Report: The balance was reported at \$17,889.57 as of December 31, 2018
- f) Suggestion Box: There was nothing to report.
- g) Committee Reports: Committees were assigned as follows.
 - 1. Social Committee Nate, Tim, and Jane
 - 2. Worship Committee: Karen Wollenburg. Karen also reported on worship committee events for the past month.
 - 3. Evangelical/ Stewardship Committee: Deb Schwann, and Lana Hager
 - 4. Parish Education/VBS Committee: Mike Holtmeier. Mike also reported that since there is no one elected to the position of Sunday School Superintendent, that program will be headed by a committee with input from the Parish Education Committee and Pastor Koos.
 - 5. Confirmation Committee: Mike Holtmeier, Tim Garrison, Pastor Koos. Mike presented an update on the Confirmation process, as well as, the Mentoring program.
 - 6. Youth Group Committee: Brian Smidt
 - 7. Property Committee: Tim Garrison and Steve Garrison. It was reported that the bell tower should be repaired in February or March. Also, landscaping to north of the fellowship hall will be continued, as well as, removal of thorny bushes on the west side of the church. Lawn mowing of the church will continue to be contracted to the Arlyn and Elaine Parde.

II. Old Business

 The "Wedding Cleanup" protocol for couples wishing to be married at Trinity continues to be under review.

III. New Business

- Council Members signed up for Communion Assistant for the current year. See included.
- b) Lawn care for the church and parsonage was discussed. There was a motion by Karen and a second by Tim to contract with Courtney's, who was the provider last year. The motion carried.
- c) The heating and air conditioning service was discussed. There was a motion by Brian and a second by Tim to continue to use Richter's Service of Seward for twice a year maintenance at a cost of \$545. The motion carried.

There was a motion by Tim and a second by Brian to adjourn the meeting. The motion carried. In conclusion of the meeting, the council recited the Lord's Prayer.

- 7. What happens if we don't forgive people that need to be forgiven? (Matthew 6:15)


