April 17, 2019

I. Call to order

Chairperson Mike Holtmeier called to order the regular meeting of the Trinity Lutheran Church Council on April 17, 2019. Pastor Koos led the group in devotions. Members in attendance were Pastor Koos, Steve Garrison, , Karen Wollenburg, Tim Garrison, Brian Smidt, Lana Hager, Nate Morrissey, Mike Holtmeier, and Jane Stokebrand. Also, in attendance were confirmation students Jackson Kirchoff, Joshua Muehling,, Payton Smidt, Taden Gronemeyer.

II. Reports

- a) Secretary's Report: A copy of the previous minutes was reviewed. Tim made a motion and it was seconded by Nate that the minutes be approved as amended. Motion carried.
- b) Treasurer's Report: A copy of the monthly treasurer's report indicated a balance of \$2,399.46 as of March31, 2019, Steve made a motion to accept the report and it was seconded by Brian. Motion carried.
- c) Investments Report: Tim reported the investment account to be \$53,328.34 as of March 29, 2019.
- d) Pastor's Report: See included report.
- e) Memorial Report: Nate reported the balance of that account to be \$17,898.49 as of April 17, 2019.
- f) Suggestion Box: There was nothing to report.
- g) Committee
 - 1. Spiritual Life and Growth
 - a) Social Committee had nothing to report.
 - b) Worship Committee: Karen reported on Sunday School Recognition scheduled for May 5th, the Synod Assembly in June, and Pastor's 5th year Anniversary in June.
 - c) Evangelical/ Stewardship Committee had nothing new to report.
 - 2. Youth Development
 - a) Parish Ed/VBS: It was reported that the Baked Potato Bar raised in excess of \$1,000.
 - b) Youth Group Committee: Brian reported that Kelly Smith will complete the painting of the room that group uses. Kelly also said that a service project is planned for 2020.
 - 3. Care, Management and Overview
 - a) Property: The property committee reported that the bell tower will wait until the fall for repair due to weather conditions
 - b) Tim also reported the Spring Clean Up was successful with cleaning and landscaping projects accomplished.
 - c) It was also reported that the leaking toilets, garbage disposal, and lighting on the west side of the church have been repaired.
 - d) It was noted that the lighting in the marquis is not working.
 - 4. Pastor's Report: See included.

Bible Study Questions Wednesdays, 8:30 a.m. June 2019

06-05-19 Acts 2:1-4/Romans 8:14-39

- 1. The apostles were filled with the Holy Spirit (Acts 2:1-4). How did this experience differ from John 20:21-22 (See 1 Corinthians 12:1-3)?
- 2. What is the significance of the Holy Spirit descending on this specific day (namely, Pentecost)?
- 3. How do we often explain the presence of the Holy Spirit in our lives? Is your perspective grounded in personal experience, scripture or some other thing?
- 4. Can you be a believer and not be filled with the Spirit? Give Biblical support for your answer!
- 5. What does it mean to be "led by the Spirit?" Is it active or passive on our part to be led by the Spirit? How does being led by the Spirit prove that we are children (sons) of God? (Rom. 8:14)
- 6. What is "the spirit of slavery?" Why does having this spirit cause a person to "fall back into fear," and to what "fear" is Paul referring? How is a believer's life different from this (v. 15)?
- 7. What exactly does it mean for believers to be "heirs of God" (i.e. are we heirs of God Himself? heirs of His inheritance? something else?) and "fellow heirs with Christ?" Are these 2 phrases referring to the same thing or to different things? How do you know?
- 8. How does Romans 8:31-39 reassure those who are Christ followers that their place in God's family is permanent (Eph 1:12-14)?
- 9. If you had to describe "the love of God in Christ Jesus our Lord" to another person, how would you describe it?
- 10. Read Romans 5:1-11. How does that passage compare to Romans 8:31-39?

- 1. Why is God more worthy of praise than sports stars and politicians?
- 2. What do we mean when we say "God is transcendent?" What do we mean when we say "God is imminent?"
- 3. What is the best example of the imminence of God?
- 4. Give several examples in Christ's ministry where He raised the poor out of the dust.
- 5. Why have many women lost an appreciation for having children? Why do they prefer barrenness?
- 6. What are the things that motivate you to praise God?
- 7. Of the three reasons this psalm gives for praising the Lord, which one seems most significant to you today? Why?
- 8. How do you perceive God when you read that He "stoops down to look on the heavens and the earth"? How does this perception of God put space exploration into proper perspective?
- 9. How do verses 7-9 highlight God's compassion?
- 10. Why is it humbling to embrace that we cannot understand what is to come?

- 1. In your opinion, what's the greatest suffering that one could go through?
- 2. Is there somebody or even a group of people that has ever made you feel like an outcast for something you did or said?


