All in all, I think our shared ministry was a great success and I will forever be grateful for it.

Though I am resigning my leadership, the ministry of Trinity Lutheran in DeWitt, NE will carry on. The future may be uncertain but this congregation has a lot of strong leaders and a secure framework. I am confident that the NE synod will do everything it can to ensure the further success of this congregation. The call process will be a timely process but that is for the benefit of this congregation. It deserves strong pastoral leadership and, like all good things, it'll take time to identify such leadership. Be faithful and assured that God will walk with you through the process. You've heard me preach it over and over: our God is a good and gracious God. He WILL provide for you...maybe not what you want but certainly what you need. Trinity Lutheran Church Minutes

September 19, 2019

I. Call to order

Chairperson, Mike Holtmeier called to order the regular meeting of the Trinity Lutheran Church Council on September 19, 2019. The regularly scheduled meeting was postponed until September 19th. Pastor Koos led the group in

Members in attendance were Pastor Koos, Steve Garrison, Tim Garrison, Brian Smidt, Lana Hager, Deb Schwan, Mike Holtmeier, Karen Wollenburg, Nathan Morrissey, and Jane Stokebrand. Guests in attendance were Bev Plihal, Lois Wattjes, Doug Stokebrand, Harold Stokebrand, and Pastor Rick Johnson, St Paul's Soap Creek Lutheran Church.

- a) Secretary's Report: A copy of the previous minutes was reviewed. Amendments included correcting a spelling error and adjusting the number of confirmation students from 6 to 5. There was a motion by Tim and a second by Deb to approve the minutes as amended. Motion carried.
- b) Treasurer's Report: A copy of the monthly treasurer's report indicated a balance of \$8,633.64.
- c) Investments Report: Tim reported the investment account to be \$54,145.43
- d) Pastor's Report: See included report.
- e) Memorial Report: Nate reported a balance of \$16,359.86 after reimbursement to the General Fund for the Splash Packs at \$319.88, first grade Bibles at \$153.92, and fifth grade Bibles at \$148.45.
- f) Suggestion Box: There was a signed question in the Suggestion Box regarding whether or not an entry exam is required to begin confirmation class. Chairperson, Mike, as a member of the Confirmation Committee, addressed the question, stating there is testing at the confirmation process level to be successfully completed before beginning confirmation.
- g) Committee Reports
 - 1. Spiritual Life and Growth
 - a) Social Committee: Nate provided information regarding a tailgate party that could be scheduled for October 11, 2019. Tim had spoken to Mr. Uher, Tri County principal, who approved the event if scheduled. All people attending the football game that night would be welcome to attend at no cost. Council members were in favor of this project and a signup sheet will be provided for congregation members to provide food items to include hotdogs, chili, condiments and chips.
 - b) Worship Committee: Karen reported that the committee had met with events as follows: Reformation Sunday will be October 27th with the Soap Creek congregations being our guests. Megan Morrow, from the Evangelical Lutheran Church of America (ELCA) will be in attendance and serving as the speaker. Coffee, juice, kolaches, and donuts will be served before and after the service. The Sunday School choir will sing and the Soap Creek children's choir will be invited to participate in singing.

The Noisy Offering will be designated for the Bible School fund.

There will be no adult choir in the month of January

- c) Evangelical/ Stewardship: Nothing new to report.
- 2. Youth Development
 - a) Parish Ed/VBS: Mike reported that Sunday School was off to a successful start and there is still a need for teachers.
 - Youth Group Committee: Pastor reported that the Sunday School room has been repaired.
 - Confirmation: Confirmation has begun with 4 students enrolled.
- Care, Management and Overview
 - a) Property: Tim reported that he has not yet received an estimate from Thrasher for repairs needed for the parsonage basement. Tim, also reported that the lawn irrigation system has been closed for the year, Mitch McDougal provided material to spray the church lawn for sedge, and that the apple tree in the parsonage lawn will be removed due to rotting apples.

4. Pastor's Report: See included. Pastor requested permission to attend the Fall Theology Conference and the Oblate Retreat both held in October. There was a motion by Lana and a second by Tim to allow Pastor Koos to attend those meetings. Motion carried.

II. Old Business

a. Old business consisted of the item tabled from last month's meeting; to determine whether or not the council should go forward with the required process for leaving the ELCA. There was a motion by Jane and a second by Lana that Trinity Lutheran Church of DeWitt Nebraska maintain affiliation with the Evangelical Church of America. Discussion was as follows:

Pastor Rick Johnson was present to answer questions and provide insight. He addressed the questions "What does the ELCA do to support us?". Pastor Johnson described some of the items of support to include the Rural Crisis Hotline, Youth Ministry including Camp Carol Joy Holling, Campus Ministry, Tabitha services, and providing access to pastors who have been carefully vetted for service to Trinity Lutheran Church and other congregations, and several other items. Pastor Johnson also provided insight into the information detailed in the State and National Assemblies.

Mike voiced concerns about statements and stances made by leadership of the ELCA and the decline in attendance in protestant congregations in the United States, as well, as in our local church.

Following discussion the motion by Jane and Lana was rescinded with their permission. There was a motion by Brian and a second by Steve that the Trinity Lutheran Church Council cease discussion about severing ties with the ELCA. After further discussion, a vote on that motion was called for by the president. The motion carried without opposition.

III. New Business

- Mike presented information from Camp Carol Joy Holling regarding a fund raiser for a new building. No action was taken.
- b) Mike presented a request by WELCA regarding the purchase of new chairs at a cost of \$24 per chair. There was a motion by Tim and a second by Steve to approve WELCA to seek donations for the chairs. For every chair purchased by a congregation member, a chair now owned by Trinity Lutheran Church would be donated to the DeWitt Community Center. Following discussion, Mike called for the vote. The motion carried.
- c) There was a closing statement regarding the need for TLC council members to now come together to seek common ground and to move forward with the work of the church.

There was a motion by Brian and a second by Tim to adjourn the meeting. The motion carried. In conclusion of the meeting, Pastor Koos led the council in recitation of the Lord's Prayer.

Congregational Ethics: Members Relating to Former Ministers

We believe that the Holy Spirit is acting when a person is called into ministry. We also believe that the Holy Spirit is acting when it is time for that minister to accept another call; including the call into retirement. How the congregation responds to previous ministers is critical for the health of the congregation and the entire Church. Unhealthy ties to former ministers will negatively impact the congregation's ability to receive the ministry of the ministers that follow.

Congregational members make and maintain loving and caring relationships with their ministers and their family members. Within the realm of friendship, it is appropriate to continue such relationships. Hospitality is always proper. It is not appropriate to engage former ministers in discussions or to seek their advice concerning congregational matters or the current pastor.

Likewise, members should not turn to a former minister at emotional and ceremonial times with expectations that the person will perform any pastoral acts; i.e., weddings, funerals, baptisms, home communions, etc. Such requests immediately put both the current and former minister in very awkward positions. You can show high regard for the pastoral office your former minister held by seeking out the new minister to be your minister.

When a new minister begins to serve, whether called by the congregation or as a transitional minister under contract, it is the responsibility of each member to love the new minister, forgive him/her, and to turn to him/her for pastoral leadership. The concern of not knowing, or being known, by the "new" minister is each member's responsibility to address.

When a minister leaves a congregation, especially in the midst of conflict, it is inappropriate to speak negatively about the former minister and diminish the possibility of her/him moving forward in a new ministry relationship. The challenge is found in Luther's word, "but defend them, speak well of them, and put the best construction on everything" (The Small Catechism, 8th Commandment).
