Greetings to all who are reading this page/article/column. I couldn't decide what exactly to call it. I think of it as more of a column than a report for the monthly newsletter. I like to give my thoughts on what is going on, what I'm seeing, what I'm thinking, and I welcome your feedback at any time. I'm Pastor Travis Panning. I'm the new guy on the block, but not as new as some new ones would be. I've been serving as the Pastor up at First Lutheran Church in Wilber for the past 8 years, and I've been to Trinity many times, but it's always as a guest of the pastors who were serving here at the time. We get together for text study every Tuesday. I've served in this cluster of churches, the Homestead Cluster, my entire 13-year career. Professional ministry is my first and only career. My first call was at State Line Lutheran Church south of Wymore (2006-2011). At that time, it was Pastor Ken Kramer serving here, and then 5 years ago Pastor Sean Koos came to serve here. With both of them, I've known and cherished the professional relationships that were available to me. Especially Pastor Koos. He is a good friend of mine. He was there for me during some challenging times and I enjoyed his collaboration on a Bible Study that he was a part of that I led up in Wilber.

As this congregation begins to explore what its future will look like, I will strive to stay neutral. I do have a bias, but I don't trust shortcuts. There is procedure in place for a reason, and it would be easy to jump to what appears to be an easy solution. We need the congregation to be sure of its decision on its own footing. That process is the Call Process, and it includes some great opportunities for the congregation to do some self-evaluations. The more we know about ourselves, the better. To restate what the official situation is: I'm serving here as the Transitional Minister during the transition from the last pastor to the new one. Those contracts are 6-month contracts, and it will be revisited in June when we can extend it or change the agreement. In a departure from norms, I do have the opportunity to move into the regular call here. Usually, the procedure dictates that the transitional minister is ineligible to then become the regularly called pastor. This is because the transition for a congregation is a time of doing some honest reflection, some "spring cleaning," and this is more efficiently done by someone who can maintain objectivity. But with the shortage of clergy available, that kind of objectivity may be more of a luxury as time moves along. The challenge before us will be whether or not we're able to treat the transition as the opportunity for open evaluation and reflection on existing ministry that it is.

After my first six weeks here, I am impressed with many facets of the congregation. One of those facets is that I deeply enjoy Bible study, so the availability of regular bible study on Wednesday morning is exciting to me. That's where my passion is. The Bible is our story, our origin story. It is the product of God walking with his people over the course of around 1500 years or so. That's a lot of lifetimes of experiences, lessons learned, failures made, and it's all been condensed down into this message, this narrative collection that God has a heart for the world he has made, that he sees it is broken, and he has a plan for restoring the world back to himself. We continue that plan today. The men's bible study is 2nd and 4th Wednesday mornings of the month at 6:30. The open bible study is every Wednesday morning at 8:30. You're all invited to come.

There are also opportunities in my opinion. The overall church is currently redefining itself as it moves away from many of the modes that have kept it running literally for centuries. The church is having to ask itself What Is Our Purpose after all those generations of mixing with political purposes, after banking on fear or guilt to line people up in pews, after defining itself and defending itself largely over and against competing church bodies. In my opinion, the church has an opportunity to be getting more back to its roots. Those roots, to me, are all drawing from Jesus, from the story about Jesus, from the example that he set for us, from the disruptive force that he was in the trajectory of the world. The church has been changing lives for the better for 2000 years. God isn't done with her yet. It might not look like it has before, nor does it have to. How can we be the church in the year 2020 in De Witt, NE at Trinity Lutheran Church? Let's find out together!

Trinity Lutheran Church Minutes

December 18, 2019

I. Call to order

Chairperson, Mike Holtmeier called to order the regular meeting of the Trinity Lutheran Church Council on December 18, 2019. Members in attendance were Tim Garrison, Karen Wollenburg, Steve Garrison, Deb Schwan, Jane Stokebrand, Mike Holtmeier, Nathan Morrissey, Brian Smidt and Pastor Panning.. Reports

- a) Secretary's Report: A copy of the November Council minutes, the Special Council Meeting of November 19, the Special Council Meeting of Nov 5, 2019, the Special Council Meeting Dec 2, 2019, and Special Meeting of the DeWitt/Wilber Council were reviewed. There was a motion by Tim and a second by Deb to approve the minute. Motion carried.
- b) Treasurer's Report: A copy of the monthly treasurer's report indicated a balance of \$6958.15. Because the position of Treasurer of Council will be changing there was discussion of the amount of \$1,000, which is grant money to be distributed to Parish Education to be divided between the Care-a-Lot, Confirmation, and the mentor program.
- c) Investments Report: Tim reported the investment account to be \$57,102.84.
- d) Memorial Report: Nate reported a balance of \$16,366.63.
- e) Suggestion Box: None.
- f) Committee Reports
 - 1. Spiritual Life and Growth
 - a) Social Committee: Nothing new to report.
 - b) Worship Committee: Karen reported that the committee will meet sometime after Pastor Panning begins his ministry at Trinity Lutheran.
 - c) Evangelical/Stewardship: Nothing new to report.
 - 2. Youth Development
 - a) Parish Ed/VBS: This committee did not meet in December, but is scheduled to meet in January.
 - b) Youth Group Committee: Brian reported that the Youth Group completed a service project in December serving at the People's City Mission. They are planning another Mission Project for July 5th through 10th. The group is selling pies to be delivered before Christmas to raise funds for that Project.
 - c) Confirmation: Mike noted that the committee will need to meet with Pastor Panning.
 - 3. Care, Management and Overview
 - a) Property: Tim reported on an estimates by EppConcrete and Tillotson Co. to make necessary maintenance to the parsonage due to water concerns. The EppConcrete bid came in significantly lower with a final payment of \$8,250.00 and a down payment of \$835.00 due at bid acceptance. The council discussed that the reverse osmosis system in the parsonage should be cancelled. Culligan Corp. will be notified. Tim has also made inquiries into hiring a cleaning company to clean the parsonage. There is some furniture left at the parsonage. Dispersion of that property is scheduled to be addressed at the Annual Meeting.
 - 4. Evangelical Report: Nothing new to report.
 - 5. Pastor's Report: The Council reviewed an email sent to Mike by Zachary Powers. Pastor Koos had personally hired him to set up the Power Point for our services. He will continue to provide that service through the month of December and Trinity Lutheran will pay for that out of church funds. Pastor Panning will take over that duty when he begins his contract. Pastor Panning will require a refurbished Mac Projector set up to do

this at a cost of approximately \$350. Pastor Koos had personally been paying Zach Powers \$50 per week for that service.

III. New Business

- 1. There was a motion by Brian and a second by Deb to pay the remaining budgeted amount of \$3,000 to Mission Share of the Evangelical Lutheran Church of America. (ELCA).
- 2. There was a motion by Karen and a second by Nate to accept the Letter of Agreement for Transitional Ministry for Pastor Panning. Following discussion to remove question marks and strike outs present in the document, as well as, the specification of the pay date to be the last day of the month, the motion carried. Payment will be made to First Lutheran of Wilber in the form of reimbursement.
- There was a motion by Tim and a second by Steve to accept the Model Constitution as approved by the 2019 Church Wide Assembly and to recommend it for approval at the Annual Meeting. The motion carried.
- 4. There was a motion by Karen and a second by Nate to accept the six remaining members who have volunteered for the Call Committee. The motion carried. The Call Committee consists of Liz Poessnecker, Nancy Mahloch, Josi Remmers, Chris Woerner, Tom Koch, and Arlyn Parde.

There was a motion by Brian and a second by Nate to adjourn the meeting. The motion carried. In conclusion, Pastor Panning led the group in praying the Lord's Prayer.


